EXPLANATORY NOTE

This Registration Statement on Form S-8 (this "Registration Statement") registers the offer, issuance and sale of a total of up to an additional 2,374,292 ordinary shares, par value New Israeli Shekel ("NIS") 0.01 per share ("Ordinary Shares"), of Stratasys Ltd. ("Stratasys," the "Company," the "Registrant," "our company," "we" or "us") to Stratasys' and/or its subsidiaries' officers, employees, directors and consultants under the Stratasys Ltd. 2022 Share Incentive Plan, as amended (the 2022 Plan"). All of these Ordinary Shares are available for issuance pursuant to potential future grants under the 2022 Plan.

Pursuant to Instruction E of Form S-8, the contents of the Company's registration statement on Form S-8, Commission File No. 333-270249, filed with the Securities and Exchange Commission (the "Commission") on March 3, 2023, covering offers, issuances and sales of Ordinary Shares under the 2022 Plan, are incorporated herein by reference, and made a part of this Registration Statement, except as amended or supplemented by the information set forth below.
